# 27 Feb 2014

Election Commission publishes Election Calendar/Guidelines on the NAV website.

#### 08 March 2014

Note: The election is open for all registered NAV members (renewed or new members) irrespective of when they became members.

The cut-off date for the eligibility to stand for the NAV official posts in the election was 08 March 2014. Beyond this date, NAV entertains the NAV memberships who can participate only in the voting. The distribution of memberships will close on 12th March 2014, midnight.

#### 10 March 2014

The Election Commission publishes the list of eligible registered/renewed members, who can be nominated for candidacy for elections as an Office Bearer or as an Executive Members on the NAV website by 10 March 2014, midnight.

#### 12 March 2014 by Midnight

Election Commission accepts application for candidacy in the following nominated email: election.nav@outlook.com

#### 12 March 2014 Midnight

The distribution of memberships will close on 12th March 2014, midnight.

# 13 March 2014 by Midnight

Election commission publishes the first list of candidates.

#### 14 March 2014 PM

Election Commission accepts the withdrawal of candidates in the following nominated email: election.nav@outlook.com.

#### 14 March 2014 Midnight

Election Commission publishes the final list of candidates.

# Saturday, 15 March 2014 (Election Day)

10 AM – Election Commission publishes the list of the final voters.

10 -11AM - Call for candidacy for vacant positions only.

11:30 AM - Election commission will declare the final list of candidates.

12Noon – 1PM - Voting

# 4. NAV Election Commission (EC)

#### **Election Commissioner:**

#### **Code of Conduct of EC Members**

- All EC members should be independent;
- EC members should not advocate in favour of or against any candidate;
- EC members should not involve in any activities that undermine friendship, cooperation and harmony among NAV members, such as panel fixing;
- Members of EC are not allowed to apply for candidacy for the NAV Executive positions;
- EC members are bound to maintain confidentiality of the information as appropriate; and
- All email communication(s) between EC members must be kept confidential and should only serve for the best interest of the NAV election purposes.

The NAV Election Commission will be dissolved after oath of newly elected Executive Officials and Members.



#### 5. Election Process

- Election Commission will accomplish the activities outlined in the election calendar;
- Election will be held at a pre-determined polling centre. All registered members will be informed on the NAV website and Nepali media to participate in the election process;
- All registered members are requested to participate in the election process;
- No proxy votes are allowed. Members must be present in person in the polling centre to be eligible to vote;
- All registered members must bring identification cards such as a driver's license, passport, student card or any photo ID for identification purposes. Election Commission allows the registered members to cast his or her votes, only with an appropriate identification card;
- The winner in the election will be decided on who secures a simple majority
- There will be a no campaigning at the poling centre.

Executive Members - 5

# 7. Application for Candidacy

- All candidates must file their candidacy by completing the application form and it must be signed by both proposer and supporter.
- Please note that the same proposer and supporter cannot be a proposer and supporter for other candidates.
- Proposer & Supporter should be a valid NAV Member.
- The completed application form should be scanned and emailed to election.nav@outlook.com.
- A brief profile of the candidate (not exceeding one page) should also be attached with the application form so that it can be published on the NAV website. Candidates are also requested to briefly write what they want to achieve for NAV during their tenure, if elected (Election Manifesto).
- Please send your completed application form and election manifesto in PDF format. The Election Commission does not accept information sent via iPhone/Smartphone or in word format. Your application will be invalid, if you don't send it in PDF format.
- By lodging an application for a position, the applicant is considered to have given consent to disclose their relevant information for the purpose of the election (for example, displaying their name, address etc. on the screen and physical/ electronic voting system to members).
- Election Commission will verify the registered membership validity and approve the validity of the candidacy.
- Final list of candidates will be published on the NAV election site.



- A decision taken by the EC will supersede any prior decisions or anomalies should there be confusion or disputes in matters relating to the election process.
- Election Commission will prepare the ballot of candidacy by surname in alphabetical order.

# 8. Jurisdiction of Election Commission

Election Commission will reserve the right to make decisions in relation to election matters including but not limited to:

- Determining date, time, and location of the election
- Procedure, method, equipments to be implemented for the election
- Resources, support team members necessary for the election
- Counting methods for the casted votes
- Approving the allowed human and physical resources necessary at the voting booth and during the vote counting process.

# 9. Disputes and Conflict Resolution

Decisions made by the Election Commission would be final and binding in case disputes or conflicts arise in relation to the election guidelines, procedures, interpretations and any other unforeseen matters during the course of the election.
